This plate is available only through the Marine Corps League and will be assigned only to vehicles registered in the members name. This form will be accepted when accompanied by an accepted method of payment, **DMV Form CP-30**, and with the Consent for Release of Personal Information notarized. Please allow 4-6 weeks for delivery. You must be a member in good standing to be eligible for the Marine Corps League License Plates. If you become delinquent with your Marine Corps League dues, you are no longer entitled to the Marine Corps License plate, at which time the Department of Motor Vehicles will revoke your plates. Once you become a member in good standing again, you will need to reapply and pay the associated fees.
