# Obituaries

#### Alfred Hatzmann

Alfred Hatzmann of Ossining, NY who died peacefully at home on Sept. 12, 2015 at the age of 92. He was born May 2, 1923 in Tarrytown, NY to Alfred & Rose (Kacian) Hatzmann. Alfred graduated from Ossining High School in 1941. He served as a Staff Sergeant in the US Marine Corps during WWII in the Pacific Theater in the Air Squadron VMB 423 from 1942 - 1945. He was awarded the Navy & Marine Corps Medal for Heroism. Alfred married Marjorie Harbort on July 10, 1948. After the war, Alfred graduated from Pace University and worked as a Tax Accountant for the New York Central Railroad. After leaving the railroad, he owned and operated his own Landscape Company for over 30 years. Alfred was a founding member of Torview Swim Club. He enjoyed watching golf, gardening, attending his grandchildren's baseball and basketball games and his annual Marine Corps Squadron reunions. He was pre-deceased by his brothers Harold & Edward and sisters Helen, Joan and Emily. He is survived by his wife Marjorie, daughters Wendy Tarricone (Paul), Marjorie Rose Hatzmann, grandchildren Michael & Peter and brother George and many nieces and nephews. He was reposing on at Leach & Thomas, Inc.in Ossining. Mass of Christian Burial was held at St. Augustine's Church, and burial at Kensico Cemetery.

### James W. Lynch

James W. Lynch, longtime resident of New Rochelle passed away at home with his family around him on September 28, 2015, at the age of 85. Born in



Brooklyn to James and Helen Henderson Lynch. He was predeceased by sisters Muriel Lynch, Helen McWilliams, and brothers Dr. Richard Lynch, Dr. William Lynch and Brian Lynch.

He served his country in combat (U.S.M.C., 1st Division) during the Korean War from 1950-1953 earning the rank of Sergeant. After the war, he attended St. John's University, graduating in 1958 with a B.A. in Accounting.

Jim met and married Margaret Raftery of the Bronx on January 18, 1958. He was a financial executive at Corning Glass Works in Corning, NY until 1971, when he relocated the family to New Rochelle, serving as president of Salton, Inc. He was a life-long and ardent fan of the New York Yankees.



# In Loving Recognition Of Memorial Day And All That Our Fathers, Mothers And Families Sacrificed That We May Be Free

The inscription on this Memorial Declaration Plaque was from a letter written by Cpl. Frank Gambino, U.S. Marine Corps, 3Bn-COL-23 Regt. 4th Division, on the Battle of Saipan, June 15, 1944 where he describes the Battle -The Marines - Their Beliefs and the loss of his Squad Leader, Cpl. Joseph G. Romano.

Cpl. Frank Gambino's life ended on February 23, 1944 where he was awarded the Silver Star. A copy of the letter is in the Church and Memorial Services have been held monthly.

"These are our dead and we, their comrades, are the living. Our task is to continue the struggle for which they gave their lives. They shall not have died in vain. Make us worthy of their memory."
