#### DUES CHANGE:

Pursuant to a vote of the membership in September 2016, membership dues have now increased by five dollars (\$5.00) which took effect on 1 January 2017. Renewals have increased from \$31.00 to \$36.00 and New members have increased from \$35.00 to \$40.00. To complicate matters, National HQ at their annual convention has made a change to where every annual member dues will, upon renewal have an expiration date of 31 August. To facilitate the changeover there is





a pro-rate system in place:

Renewals:

If your expiration date is from July 2016 to December 2016, and you have not yet renewed, your renewal fee will be \$36.00 and your expiration date will be 31 August 2017. If you wish to renew to include 2018 then your renewal fee will be \$72.00 and your expiration date will be 31 August 2018.

If your expiration date is from January 2017 to June 2017, your renewal fee will be \$18.00. Your expiration date will be 31 August 2017. If you wish to renew for 2018 then the total due will be \$57.00 and your expiration date will be 31 August 2018.

New Members:

From now until February the new membership fee will \$40.00 and the expiration date will be 31 August 2017.

From March 1 until end of July the new membership fee will be \$22.00 and the expiration date will be 31 August 2017.

Please note that the National database does not support 31 August, therefore your cards will read as 1 September, however all annual memberships moving forward will expire on Midnight on 31 August.

Our online PayPal has been updated with the new rates, but cannot accommodate the adjusted pro-rates mentioned above. Reminder emails will be sent out which will include links options to pay via PayPal.



PFC Gonzalez completed Marine Corps Combat Training at Camp Geiger, North Carolina and was then sent to Marine Corps Communications Electronic School, at Marine Corps Air Ground Combat Center in Twenty-nine Palms,



California. She was an honor graduate and was promoted to the rank of Lance Corporal.

LCpl Gonzalez then reported to Communications Company, Third Force Service Support Group, Okinawa, Japan for duty as a communications technician. She attached to the 31st MEU and served as a member of an Evacuation Control Center Team. She participated in mock amphibious landings on both Iwo Jima and Shoal Water Bay, Australia.

LCpl Gonzalez then reported to Marine Wing Communications Squadron 38, Miramar California. She was promoted to Corporal in October of 2001. While there, she attended Marine Corps Martial Arts Green Belt Instructor Course. In February of 2003, Cpl Gonzalez deployed in support of Operation Enduring Freedom and Operation Iraqi Freedom.

Cpl Gonzalez then attached to 3rd Radio Battalion, Marine Corps Base, Kaneohe Bay, Hawaii where she worked as a Publications NCO, S&R Clerk, and a Platoon Sergeant. She was promoted to Sergeant in September of 2004. In 2006, Sgt Gonzalez transferred to Head Quarters Battalion G-6. Sgt Gonzalez served as the Civilian Billing Chief.

Sgt Gonzalez was then transferred to Twentynine Palms to attend Ground Data/ Communications Maintenance Management Technicians Course in 2007. She was promoted to Staff Sergeant in April of 2008.

In July of 2008 she attached to 6 th Communications Battalion; she served as a Platoon Sergeant, Company Gunnery Sergeant, MIMMS Chief, and Maintenance Management Chief. She also served as an Embarkation

and Food Service Chief. SSgt Gonzalez received orders to the Drill Field in May of 2012.

Staff Sergeant Gonzalez reported to Drill Instructor School in October of 2012. She graduated in December of 2012. She was the honor graduate and the class iron woman. SSgt Gonzalez reported for duty to 4th Battalion, Papa Company in February of 2013.
