

CURRENT BYLAW:

SECTION 2-00 AMENDMENTS - OPERATIVE BYLAWS.

a-00 a-00 Procedures for revisions or amendments are set forth as follows:

To be Published in the Department website at least 60 days before the convention

To be Published in the Department Newsletter in the issue prior to the convention and to be distributed by Area Vice Commandant to all detachments following the Spring Staff meeting.

Any and all changes, modifications or addition to the Bylaws of the Detachment, which do not provide for an effective date, shall be in effect upon the close of the Department Convention at which it is approved.

PROPOSED CHANGE:

a-00 Procedures for revisions or amendments are set forth as follows:

- Proposed revisions or amendments are to be submitted to the Department Judge Advocate for review. Upon acceptance that is it in the appropriate format, and free of technical and spelling errors, the Judge Advocate will ensure that all proposed revisions or amendments are sent to the appropriate staff so that they can be:
- Published in the Department website at least 60 days before the convention
- Published in the Department Newsletter in the issue prior to the convention

and to be distributed by Area Vice Commandant to all detachments following the Spring Staff meeting.

All changes, modifications, or addition to the Bylaws of the Detachment, which do not provide for an effective date, shall be in effect upon the close of the Department Convention at which it is approved.

RATIONAL:

To clarify requirements and procedures to submit Department bylaw revisions and amendments.

- 6. South Central: Broome, Chenango, Cortland, Delaware, Otsego.
- 7. North: Clinton, Essex, Franklin, Hamilton, St. Lawrence.
- 8. East: Albany, Columbia, Fulton, Greene, Montgomery, Rensselaer, Saratoga, Schenectady, Schoharie, Warren, Washington.
- 9. Metro-NY: Bronx, Kings, New York, Richmond.
- 10. Long Island: Queens, Nassau, Suffolk.

- 4. Northwest: Cayuga, Genesee, Livingston, Monroe, Ontario, Orleans, Seneca, Wayne, Wyoming, Yates.
- 5. North Central: Herkimer, Jefferson, Lewis, Madison, Oneida, Onondaga, Oswego.
- 6. South Central: Broome, Chenango, Cortland, Delaware, Otsego, Tioga.
- 7. North: Clinton, Essex, Franklin, Hamilton, St. Lawrence.
- 8. East: Albany, Columbia, Fulton, Greene, Montgomery, Rensselaer, Saratoga, Schenectady, Schoharie, Warren, Washington.
- 9. Metro-NY: Bronx, Kings, New York, Richmond.
- 10. Long Island: Queens, Nassau, Suffolk.

RATIONALE:

To balance the distribution of Detachments in the respective areas mentioned above and their areas of responsibility and proximity to Area Vices.

The only Detachment in Tioga County is in Owego, which borders Broome county and the South Central Area includes Broome County. It is reasonable by proximity to include Tioga County within South Central Area.

The West Area is expansive with no current detachments on the Southern Tier and a concentration of detachments in the Erie County and adjoining area.

Cattaraugus County's largest community borders with Allegany County and has membership within a Detachment in the Southwest Area. It is reasonable to include Cattaraugus County in the Southwest Area.

Affected Detachments:

Jim Hatch Detachment #1201 (Tioga County) moves from Southwest Area to South Central Area.

Currently there are no Detachments in Cattaraugus County, however this county moves from the West Area to the Southwest Area.















Dedication Earns Congressional Recognition

Edited version of <u>Jeff Schogol</u> 's original story in <u>Task & Purpose</u> March 8, 2023

With an impressive resume, Marine Shimanski has been recognized by Congress for extreme service to his country and presented a Medal of Bravery. Throughout his four deployments, he served as a highly valued member of explosive teams, U.S. Marine Corps Forces Special Operations Command, and participant of the Navy Seal team that took down former al-Qaida leader, Osama Bin Laden, to name a few. Below are a few more highlights from his career, that prompted the award.

- * He deployed to Iraq in 2017. That May, their forward operating base was attacked by suicide bombers from the Islamic State group.
- * In a combat deployment, a vehicle that Shimanski was riding in, was hit by a roadside bomb, Shimanski survived without a scratch!
- * Shimanski helped with force protection and security measures during the attack, conducted post-blast assessments afterward, and searched the base to make sure no ISIS fighters were in hiding and preparing to attack again. His actions resulted in being nominated for a prestigious award.

By now, you may be tempted to believe that the Marine being discussed is the Marine on the left in the above picture. It is not. This is about Shaminski, the Canine!

MARINE RECEIVES QUILT OF VALOR

Marine Al Rood is an Iwo Jima survivor. He served as a radioman with the 5th Marines and witnessed the raising of the American flag on Mt. Sirabachi.

More than 50% of his platoon was lost on Iwo Jima.

The "Quilt of Valor" was presented to him on 3/5/23.

MARSOC Shimanski is a multi-, a 12-year-old Belgian Malinois. Between 2013 and 2018, Canine Shimanski was deployed to Afghanistan, Iraq, Jordan, and Somalia with U.S. Marine Corps Forces Special Operations Command, during which he searched for

explosives while under fire, said retired Marine Staff Sgt. Brandon Marquez, Shimanski's former handler.

Paraphrasing Marquez, 'it does really take a very special animal to do what he has done. He is not just another dog, he is really out there holding his weight.'

For his service with the Marines, Congress is awarding Shimanski <u>The Animals in War & Peace Medal of Bravery</u>, an award to honor service animals who have gone above and beyond the call of duty.

Marquez said he first got to know Shimanski in February 2013. By that time, Shimanski, who was born two years earlier in the Netherlands, had already received his name, and since it was unique Marquez decided to keep it.

He was trained to smell explosives and saved many lives due to his skill!

Shimanski often looked for explosives while in Afghanistan so that Marine Special Operations Teams could safely get to hastily established helicopter landing zones

During one such incident in 2014, Shimanski helped members of a MARSOC Special Operations Team reach a U.S. service member who had been fatally wounded, before the dog checked for explosives as the team rushed to LZs, where they were evacuated, Marquez wrote.

The team came under heavy fire after the service member was wounded by an improvised explosive device, Marquez told Task & Purpose.

"We immediately started taking mortar fire, heavy machine gun fire, small arms fire as we were on top of a hill, trying to work our way down to clear for more explosives to be able to land a helicopter there," Marquez said. "Shimanski, truly, he worked through rounds impacting all around him, whether it's the mortars, the UGLs – the other gun launched, little grenades that they would shoot at us – to no-kidding heavy machine gun fire, trying to hit him as he searched around. He did it truly flawlessly."

Marquez and Shimanski later deployed to Iraq in 2017. Their forward operating base was attacked by suicide bombers from the Islamic State group. Shimanski helped with force protection and security

measures during the attack, conducted postblast assessments afterward, and searched the base to make sure no ISIS fighters remained.

Also in 2017, they were part of a MARSOC team that went into Mosul. Shimanski warned the team that the water tower, that they intended

to climb, was rigged with explosives.

Marquez ultimately adopted him. He occasionally assists training other dogs at Marquez' dog training business. "He's my best friend," Marquez said. "Truly, this dog has done everything in life with me. The successes, the hard days, the good ones, the ugly ones...."


LEADERSHIP ALLEGANY

More than 400 Navajo Code Talkers served in World War II and helped win the war by using their Navajo language that proved to be an unbreakable code for radio communication.

Kinsel served during World War II in the 9th Marine Regiment, 3rd Marine Division from October 1942 to January 1946, taking part in the Battles of Guam and Iwo Jima. He was awarded the Purple Heart in 1989 for his service at Iwo Jima.

This year (2023) marked the 80th anniversary of the creation of the Navajo Code Talkers.

Three Code Talkers remain today – Kinsel, Thomas H. Begay, and Peter MacDonald Sr.



- The Saturday meeting was interrupted with sad news that Alex Kitts, North Area Vice Commandant, had passed away. Please keep his family in your prayers.
- The Zoom meeting was planned virtually to safeguard our members from the unpredictability of NYS weather. It is expected that every one of the 58 Detachments have at least one representative present. Sadly, even with the extra effort and planning done to ensure our safety, only 14 Detachments were represented. That is a sad 24%. To add more disappointment, only about half of the Area Vice Commandants joined. At one point the attendance topped out at 21 people. This is possibly the last summary that will be provided. This meeting was a pilot program that was approved by National Commandant, Johnny Baker, who will be evaluating its success, or lack there of. There is a very good chance that this option will be off the table in the future.
- If we are fortunate enough to be granted permission to hold another Zoom meeting, consider having a Detachment event to watch the meeting so that all can watch it at one time. Your detachment can have food and whatnot to make the event more enjoyable for the members. Don't worry, your Microphone can be muted.

- Saturday began with a fabulous presentation by Marine Captain Brian Hines who is a former US Marine Corps JAG (Judge Advocate General) officer and member of Father Vincent Capodanno Detachment. Professionally, he is an Attorney and familiar with the details of the Camp Lejeune Justice Act (CLJA).

BY NO MEANS, IS BRIAN LOOKING TO GET BUSINESS FROM THIS. HIS PRESENTATION IS INFORMATIONAL ONLY AND DONE OUT OF THE GOODNESS OF HIS HEART.



First of all, do NOT get one of those attorneys that advertise for a class action suit. They will charge you for picking up paper clips (just kidding). But the point is to get yourself a quality attorney.

There is certain criteria that must be met and deadlines to

be adhered to. Box 12 of one of the questionnaires asks that you designate an amount of damages (that includes potential future ones too). Do NOT be selfless here. Once this number is filed, there is no returning to refile (unless legislation changes) and increase your compensation, should the need arise. Remember that just because you request one billion dollars, does not mean that you will receive it. Your case

and claims will be reviewed before monetary compensation is provided.

Compensation does not exclude the deceased. Claims can be filed until Quarter 1 of 2024, as there is a statute of limitations for those affected between 1953-1987. In order to qualify the affected person (not necessarily military) must have been at Camp Lejeune for at least 30 days, and they don't have to be sequential. Also, the claimant must prove the damages have been incurred.

Brian offered to visit Detachments across the state to share information. I personally request that at least 20 people be present or request a Zoom meeting with your detachment. Brian's email is bwhine@protonmail.com.

Zoom Meeting Summary (continued)

- Two Detachments are in the final stages of disbanding. As reminder to all, when closing there are specific procedures that must be adhered to. One: only one check can be written after the vote to close has been passed, and that is to the Department. Two: all rifles and military displays must be returned to TACOM. These items are on loan from them. The MCL does not own them. Please contact your Area Vice Commandant when it is time to do the formalities, and you will receive proper instructions.
- There are still several members who are delinquent with dues. Granted, some of the people have passed on and national hasn't caught up with the reports yet. However, there are still a significant number of delinquencies.
- As a reminder, in order to be eligible for Life membership, all dues be current.
- Another refresher, in order to keep the MCL license plates, dues must also be current. The plates can be revoked if dues continue to be severely delinquent.
- (previous meeting) Speaking of TACOM (Tank-Automotive and Armaments Command), there are still some outstanding items that are missing documentation. Some have simply disappeared, others lack documentation. TACOM is digitizing their inventory and it is important to identify anything that your Detachment has, or has been "lost."
- Membership numbers are still a concern. To entice younger members, consider starting a Fire Team, an off-branch of your Detachment. Their purpose is to get more of the younger generation involved in the MCL. See the national website for additional details.

- Many times, the transmittals and other "paper work" has been incomplete. You are encouraged to contact your Area Vice Commandant for instructions. The Area Vice will not do it for you, instead you will be coached.
- Our Paymaster is running into difficulties because so many of the phone numbers and emails are incorrect or nonexistent. (added later) Please gather contact information from all members and forward it to the Paymaster. It is understood that some people are truly unreachable, but do your best.
- Educating our leaders is going to be a focus in upcoming year. Keeping up with the national and Department bylaws is not always easy. This will make life easier for our leaders.
 - The first of these virtual training session(s) will be for about the duties of the Paymaster. It is open to all Marine Corps League members. If a non-Paymaster learns what is involved, he/she may be willing to fill any gaps at the officers' table.
 - Let's Go School is a program that will cover many topics to learn more about the working of our League. Different instructors will be teaching different topics. The cost is a meager \$5 per person to cover the cost of certificates. The program name is subject to change.
- There may be members who wish to remain with the MCL, but do not wish to be attached to a particular Detachment. Good news! The Department is in the process of forming a Member-at-Large (MAL) Detachment. If you are interested in being part of this new Detachment, contact Steve Topilnycky at spt1@mclwestchester.org
- Dave Wiggs, Junior Vice Commandant is chairing a recruitment poster and asks that more Detachments participate. Thus far, the number of submissions is abysmal.
